9.1 Superintendent Report – Dr. Heather Griggs shared: (1) Congratulated reelect board member, Mrs. Edna Rodriguez; (2) the conference in San Francisco was very informative, we took a different route this year and looked at things that maybe we didn't know within the District, we also for the first time presented at the California School Board Association and it was an amazing experience with lots and lots of people who joined us for our session, and definitely a team effort because it was an interactive session, it was a lot of fun and a really neat experience for us; (3) as part of Silver Lakes, they have an annual scholarship and you must be a resident to and nominate a resident, so I nominated one of our RP Seniors and he is now in the top 3 running for a \$1000 scholarship and will be going to the community service student of the year award dinner with his family and will find out at that time

- if he is a winner; and (4) with that Happy Holidays and we are looking forward to Jingle Jam all next week
- 9.2 Business Updates Mr. Darrell Redmond shared: A graph with the enrollment by week of Mojave River Academy over the past 5 years, the current enrollment for this week is the highest it has been and congratulated the staff at MRA for a job well done; (2) the audits are on the agenda for tonight, but we don't have the audit for Oro Grande, we have RP and MRA are final short of an error as we discovered that they have the president of the board labeled incorrectly, we will have that corrected; and (3) first interims are on the agenda for tonight as well and you will notice that we are deficit spending in all three entities, this is directly due to the one-time expense of the construction costs related to the Regional Complex and the 16 classrooms for High School/Middle School.

Mr. Nick Higgs shared: (1) Wrapping up the Regional Complex, finishing up the landscape which should be done by end of next week; buildings are complete, and the contractor now has a punch-list for the buildings, they will be ready to move-in as we progress into January, still looking for window coverings and furniture; and (2) the stamped plans for the 16 classrooms should be out within the next 2 weeks, in January we'll be bidding out the sitework part of that project, break ground on that is expected by the beginning of February.
